The development objective of the pilot program is to improve the process for identification and use of state lands transferred to eligible, poor and formerly landless or land-poor recipients selected through a transparent and well-targeted process as indicated by: (a) the adoption rates of improved land management and agricultural production systems in SLC sub-projects; (b) proportion of land recipients which meet poverty criteria and were landless or land-poor prior to project interventions; (c) the effective implementation of dispute resolution procedures under the project, related to challenges to the land recipient selection process.

Implementation Status and Key Decisions

The project had continued good and steady progress towards achieving the PDO and its relevance remained in line with the Government's Sub-Decree 19 on Social Land Concession Program. All four PDO indicators have been achieved to date, with a minor shortfall (rate was 57 percent compared to a target of 60 percent). The activities and accomplishments have provided good lessons learned for the identification, development and sustainability of future SLC sites. To date, a total of 3,148 land recipients (104% of the target) have been selected for all SLC sites, and a total of 10,273.13 hectares (103% of the target) have been completely registered as state private land for all project SLC sites. Land has been used as follows: (i) 5,575.54 hectares (54%) for agriculture; 266.13 hectares (3%) for residences; 950.40 hectares (9%) for public infrastructure; 1,648.63 hectares (16%) for community forestry; and the balance of 1,832.43 hectares (18%) as reserved agricultural and residential lands.

The security of land tenure is considered the biggest benefit derived from the project. The first request for Social Land Concession (SLC) titling has been received by Ministry of Land Management, Urban Planning and Construction (MLMUPC) now awaiting signature by Senior Minister to officially initiate the process. Steps have already been taken to start the titling process for eligible land recipients. Expectations are for a free titling for SLC recipients or for a costing that does not exceed the (low) systematic titling fees. This will send a very positive message to project beneficiaries as well as to the broader public and press when first titles could be distributed to SLC beneficiaries in the coming months.

The life of land recipients is closely link to having of land. Having land has provided them housing security, food security and opportunities to improve their socio-economic condition. A recent survey undertaken by the project for 50 randomly selected families showed that, the average family gross and net cash income has increased (US\$2,300 gross cash income from all sources such as on-, off- and non-farm, which compared in 2011 was only US\$470 of family income when baseline data was gathered). Increased incomes enabled beneficiaries to acquire additional assets (motorcycles, cows, etc.), make shelter improvements and some of them made an effort to send their children for higher education.

The settling-in support and capacity building provided to those that have settled in the SLC sites contributed to a positive impact on improving their livelihoods. In future, the establishment of a community-based revolving fund for example, may help shift the decision making process for service delivery more towards the beneficiaries, and instill a greater sense of ownership towards change. The infrastructure works under the project have been completed since early June 2014, nine months before the project closing date. Some infrastructure outputs, particularly roads, had to be reduced compared with the original plan as the construction cost increased approximately 25% due to construction materials and labor inflation. All seven schools constructed are in operation, except the recently completed school in Thmey SLC site, which is in preparation for operation. All three health posts have completed. Two of them are in full operation while the recent one in Chambak SLC is in preparation for operation.

For sustainable use of the infrastructure investment, Infrastructure Repair and Maintenance Committees (IRMC) were established in each site. The IRMC committee facilitates involvement from community people in repairing roads and other infrastructures. the IRMC in Tipo SLC, for example, has called for emergency repair of spillway where some parts of constructed scour protection were damaged by 2014 flood through contribution their own labors and no-cost local materials. In order to effectively implement the maintenance works, it is recommended to use guidelines on local contribution collection and other relevant sections of the commune/Sangkat implementation manual.

1,762 families (57.3 % of 3,074 families move into the SLC sites and 100% of those who moved into the SLC sites have cultivated in the agricultural land about 2,302 ha (41%) of total agricultural land. They (especially those in the first four SLC sites) have started practicing/adopting the following: (a) inter/mixed cropping of cash crops with rubber, fruit trees and other permanent crops; (b) introduced permanent crops (158.2 has.); (c) water management techniques through water retention and drainage; and (d) crop rotation, among others.

Project has demonstrated and trained the 7 agricultural technologies for LRs in SLC sites as follows: 1) chicken raising in all site, 2) pig raising in all site, 3) Kampost in all site, 4) rice production in KPT and KRT, 5) fruit tree in all site, 6) home gardening in all site and 7) vegetable production and market in all site. The aim of demonstration and training provided to the land recipients to help them plan and manage their agricultural lands and backyard gardens. To date, a total of 578 courses were provided under the project which include land preparation, shaping the soil for water management, incorporating crop residue and fertilizers, planting techniques, timing of planting, etc.

There were two sources of land for LASED-SLC that reached the target 10,000 ha for SLC: (a) 94.5% from degraded forest; and (b) 5.5% from recovered illegally occupied land totalling 568.74 hectare. No land has been sourced from economic concessions.
