- Technical working from ministry has inspected the clearing process following by master plan 2007.
- Cleared land only 31 hectares and continue 2006 plan.
- Made sowing field 9 hectares.
- Planted rubber 18 hectares.
- Ministry permitted for land clearance in zone 1: 1,147 hectares by letter 6118/476 KSK dated 05 November 2007.
- Applying for land registration.
- Until 31 December 2007, Company planted rubber 475 hectares.
