- November 2006 approved master plan.
- Made sowing field 25 hectares and sowed 380,000 trees.
- Planted tectona grandis 50,000 trees along main road 8 Km.
- Constructed 8 buildings for staff and workers.
- Cleared land along border 47 Km.
- Ministry permitted for land clearance in zone 1: 2,075 hectares by letter 4079 KSK dated 27 July 2007.
