Hereby ordered

Article 1.-

Appointing 4 (four) civil servants of the Securities and Exchange Commission of Cambodia as following:

- 4- H.E. Dr. HUOT Pum** Deputy Director General of the Securities and Exchange Commission of Cambodia with the rank and privilege of Under Secretary of State
