# Introduction

 Laos is a landlocked country. It is surrounded by 5 other countries, 3 China, Thailand and Vietnam are major timber consumers

- There are 5,083km of international border and 36 border crossing points.
- Laos is not a major exporter to Europe

# Introduction

- There is a recognition that there should be a separation between *management* of the forest resource and *oversight & control*.
- At the end of 2007 the National Assembly passed Forestry Law
  - Department of Forest Inspection was created to enforce the new laws





# **Current Situation**

 In 2011 a new Ministry of Environment has been established, it has responsibility for Protection & Conservation Forests

 The current National Assembly will undertake a review of the 2007 Forest Law to reflect the new Ministry and the Department of Forest Inspection – this will clarify roles & responsibilities

# Current Context

- The next major step is to make a decision on whether and when to enter formal VPA negotiations.
  - Need to formalize institutional structure
    - Full mandate for FLEGT Steering Committee
    - Full mandate for FLEGT Focal Point
    - Senior Ministry Staff to reflect on Baseline and Timber Flow study findings
  - Need clear understanding of benefits





### Governance

- Department Of Forest Inspection
  - Works at national and provincial level, will extend to district and villages in due course
  - Currently 450 staff
- Legislation
  - Regulations
  - Decrees
  - Codes of Practice

All under review within the new Forest Law



# International Commitments

- Lao PDR is a signatory to
  - CITES
  - ASEAN -WEN
  - The Convention on Biological Diversity
  - ASEAN Senior Officials on Forestry (ASOF)
    - Commitment to TLAS by 2015
    - Generic CoC systems





# **Enforcement:**

- Whatever the policy the proof comes in what happens on the ground
  - Timber confiscation
  - Vehicles impounded
  - Mills suspended / closed
  - Wild life
  - Court cases
